He was apprehended and arrested as a spy on his way back to Manhattan Island and was sentenced to be hung the next day. On the following morning, he stood at the gallows and gave his last words---- "I only regret that I have but one

life to lose for my country"----. General Washington wept when he heard the story. Nathan Hale became a martyr and a hero, and inspired the colonists across the land fighting for independence.

KERRY BARTELS--SPEAKER

Kerry Bartels' love for family history and genealogy at an early age are what drove him to become a professional archivist. After receiving his undergraduate degree in History from the University of Oregon, he went on to graduate work and earned a Masters Degree in Library Science from Case Western Reserve University in Cleveland, Ohio. A Family History and Genealogical practitioner since 1962 and a Professional Archivist since 1977, he has worked for many years in all aspects of genealogical research, county records, state records, federal records, records of private organizations, personal papers, oral history, preservation of materials, microfilming, and many other associated fields. His career has taken him to the Indiana State Archives as an Archivist, and as a University Archivist at the University of Washington and Washington State University. Since 2008, he has held the position of Archives Specialist at the National Archives regional center in Laguna Niguel, where he spends much of his time instructing and assisting people with their family history research. His resume also includes historical societies, manuscript repositories, rare book rooms and museums. He will be speaking to us aboard the SS Lane Victory on September 19th all about the National Archives and how to locate your records. Kerry resides with his family in Orange County.

DANNY COX BIOGRAPHY

After graduating from Southern Illinois
University and receiving his commission in the
United States Air Force, Danny entered primary
pilot training and flew the T-34 and the T-28.
Graduating from "primary," he flew the T-33 in
basic training and there received his wings.

His next assignment was Advanced All-Weather Fighter Interceptor Training where he checked out in the F-86L Sabre. It was in this training that he

broke the sound barrier for the first time. That required a vertical dive in that airplane at full throttle in afterburner flying from 43,000 feet. Clark Air Base in the Philippines was his next assignment. He flew the F-86D Sabre transitioning later into the F-102 Delta Dagger in the 509th Fighter Interceptor Squadron.

During this two and one-half year assignment he was assigned to temporary duty with the Royal Australian Air Force flying out of Guiuan, Samar, Philippines and also with the Nationalist Chinese Air Force based in Tainan and Chia-Yi, Taiwan. The next assignment was Davis-Monthan Air Force Base in Tucson, Arizona where his next fighter was the high performance all-weather fighter F-101B Voodoo. This airplane held the world speed record for the time at 1200-MPH (Mach 1.75). It climbed from take-off at sea level to 35,000 feet in 1 minute and 32 seconds.

During this three and one-half year assignment he did maintenance test flights on the F-101 and flew high-speed ultra low level (25 feet) across the desert to help locate holes in the radar net. Danny also flew in air shows demonstrating the power of the Voodoo.

Another unique distinction that Danny has is that he encountered the deadly "pitch up" that was a design flaw of the Voodoo. From 56,000 feet he violently tumbled out of control losing 30,000 feet of altitude before recovering. This was the ninth "pitch-up" the Air Force had had since they bought the airplane and only three pilots ahead of him had survived.

An additional duty while in Tucson was Public Relations for his squadron, the 15th Fighter Inceptor Squadron. This entailed radio and television interviews as well as being the lead pilot in a locally produced television special called "Voodoo Rendezvous."

The next assignment was the 87th Fighter Interceptor Squadron at Lockbourne AFB in Columbus, Ohio. There he continued to fly the F-101B as a line pilot, doing maintenance testing and flying in air shows. Additionally he spoke to civilian groups in surrounding communities that

were often hit by frequent sonic booms. He was known throughout the Air Force as the "Sonic Boom Salesman."

After ten years of service, 2400 hours of high performance fighter time and breaking the sound barrier almost 2000 times he left the Air Force to enter the business world. Joining a large sales company, he built two record-breaking, industry leading sales teams that resulted in an 800% increase in production over a five-year period including two recession years.

As a full time business speaker and author, he was inducted into the National Speakers
Association's Hall of Fame and is a member of the elite 20 member Speakers Roundtable. His best selling books are, Leadership When the Heat's On, Seize the Day and There Are No Limits, now in 28 languages.

Being a descendant of the early American families such as Wiley, Shelby and Cox who fought in the Revolution, War of 1812,
Mexican--American War and Civil War, he has been accepted into the Sons of American Revolution and Sons of the Union Veterans of the Civil War. As a point of interest, his great-grandfather was a POW at Andersonville.

The 22 page document was approved by the new Executive Committee at its first meeting on July 9th in Atlanta. It will be posted on the SAR

S.S.LANE VICTORY

In early 1942 with Liberty Ship construction well established, designs for a new emergency cargo ship were drawn up. It was apparent to both commercial and military operators that a faster and more efficient design would be more competitive and useful after the war.

In March 1943 the initial plans were complete and given the designator EC2-S-AP1. The E indicated

that it was a standard emergency design optimized for rapid production. C2 indicated a medium size cargo ship with a length between 450 and 500Ft. The S indicated single screw steam propulsion. AP1 indicated the design and revision number. In April 1943 the E was changed to V.

This new design was given the name "Victory Ship" by the Maritime Commission. It could reach speeds of 15-17 knots and had five cargo holds. Upgrades on these ships included electric winches, capstans and steering gear. The hull was designed for flexibility to eliminate cracking problems they had had with other Liberty Ships. It was designed so that it could accommodate a wide range of engine types(Turbine, diesel, or Lentz engine) due to uncertainty regarding available power plants.

Delays in production were the result of conflict between the Maritime Commission and the War Production Board. The first Victory ship was launched on February 28,1944. They would eventually build 531 Victory ships before the end of the WWII.

The S.S. Lane Victory was launched on May 31, 1945. Following her sea trials she was delivered to the Maritime Commission, War Shipping Administration and American President Lines on June 27, 1945.

She began her career as a merchant ship, spending her dayscarrying military cargo in three wars, where she carried commercial cargo to ports all over the world.

During the Korean War she rescued over 7000 Korean refugees from Wonson and evacuated over 3800 U.S. troops, 1100 vehicles and 5 tons of supplies from Hungnam while under fire. She ferried ammunition and supplies to and from the war zone in Vietnam. During peace time, she traveled throughout th Far East Pacific ports,





crossed the Atlantic several times and circumnavigated the globe on one of her voyages.

During her service she became known as a model ship and was the standard others were judged by. As the Viet Nam War wound down she became the last operational Victory ship sent to Suisan Bay reserve fleet on April 29, 1970.

At this point it seemed that her career was over. Then came along John Vernick, John Smith and a group of feisty Merchant Marine Veterans. Had it not been for these men the *S.S. Lane Victory* might have continued to silently sit and decay until it was finally scrapped like her sister ships.

But, on October 18, 1988 President Ronald Reagan signed H.R. 2032 into law, conveying the S.S. Lane Victory to the United States Merchant Marine Veterans of WWII. On June 7, 1989, the ship was officially transferred to the organization, and she was towed to Los Angeles harbor on June 12.

For three years volunteers labored with donated materials to restore the ship. The cargo booms were rerigged, the winches reinstalled, water and electrical systems were restored and reactivated. The boilers and other machinery were overhauled and updated. Many of the upgrades were required to bring it up to modern Coast Guard standards.

She was dry-docked in 1992 at which time her hull was given a clean bill of health. With most of her restorations and upgrades completed, her sea trials were held on September 10, 1992. As with her first set of trials in 1945, the *S.S. Lane Victory* once again returned to the harbor with a broom flying at the main mast indicating a clean sweep! She

embarked passengers for her inaugural "Victory At Sea" cruise on October 3, 1992.

Today the S.S. Lane Victory serves as a maritime Museum and memorial honoring the achievements and sacrifices of the Merchant Marine sailors and Navy Armed Guardsmen in service tour nation. Her volunteered crew continues to keep her running and looking great.

She is in her own right a movie. She has served a a set for many feature films, television shows and commercials.

She still sails on several Victory at Sea cruises every Summer, giving veterans a chance to relive their past adventures and permitting those of us too young to remember, to get a glimpse of what life was like during the war years on the high seas.

The S.S. Lane Victory has often been said to have been named after Isaac Lane, a former slave who later became a Methodist preacher and founded Lane College to educate other ministers. The Victory Ships were named after member countries of the United Nations, cities and towns in the United States, and after American colleges and universities. This does not in any way diminish the achievements and honors Isaac Lane deserves. To be historically accurate the Lane Victory was named after Lane College and therefore is indirectly named for its founder.

The S.S. Lane Victory is a National Historic Landmark.***



Directions:

Take the 110 Freeway south, follow signs to the Vincent Thomas Bridge, HWY. 47 exit and stay to the right. The first and only off ramp before the bridge is HARBOR BLVD. Do not miss it or you will be forced to cross the bridge into Long Beach and turn around to come back!
