Lou Carlson felt we should pay the expense. Dan McKelvie moved that we have the treasury pay the expense. This was seconded by Richard Adams. The motion passed.

Arthur Koehler reported that our treasury is down to \$2200.

Richard Adams will plan a short service for Ralph Shannon. Lou asked that it be brief and soon and the charter should be draped at that time. He will plan for a memorial in May.

Arthur Koehler asked if we need a quartermaster to handle the Flags, charter, clothing and other chapter property. Jim Fosdyck keeps the Flags and Dan Shippey as President has most of the plaques and other property.

With no further business it was moved by Richard Adams that we adjourn. It was seconded by Lou Carlson.
